Board Chairman's Message



Dear Compatriots:

Our chapter is enjoying the greatest period of success in its history. At 56 Compatriots, we have more members than at any time since our chartering in 1928. Thanks to the generosity and dedication of our membership and through skillful financial management, our chapter's economic resources enable us to undertake initiatives that are much more than giving out awards and certificates- we are fundamentally enhancing the quality of education in our state. This impacts millions of youngsters from Pensacola to Key West. Most importantly, because the Initiative is a permanent program it will endure as an essential component of our mission far into the future.

Most excitingly, the role and scope of our chapter is taking on a national dimension through the dramatic success of our Education Outreach Initiative. Board Member Dr. Roger Smith attended the recent National Society leadership meeting in Louisville, and as a member of the National Education Committee he presented a report on our Tampa Bay SAR Education Outreach Initiative achievements. His report was very well received, and The TB Education Initiative is now being referenced as a national model for implementation. I am in the process of writing an Education Program Implementation Manual that can be used by other states to develop and implement Outreach Education Initiatives.

Due to time restrictions, I did not present a PowerPoint report at our October meeting. I have provided it to you in PDF form by email so you can review it at your leisure, so please check your email. The PowerPoint was presented by John Stewart at the BOM earlier this month summarizing what we have accomplished with our partners in the Tampa Chapter SAR. I am especially pleased that this presentation was received with applause, and the following day the FLSSAR Education Committee was chartered on a unanimous vote by the entire BOM.

John Stewart is the Chairman of the FLSSAR Committee, and the strategic work we have done can now be expanded to include collaboration with and support from other SAR chapters around the state. Effectively this expands our Education Initiative to represent the interests of more than 2,200 Compatriots Statewide.

As I said in my comments during the October meeting, instead of lamenting the need for enhanced early American history and Civics knowledge and comprehension by our youth, we are proactively addressing it with carefully structured plans and programs.

For the record, the TB Education Initiative began in 2017 with a meeting arranged by President Rogers and following a call to action by then President General Michael Tomme. Attending the initial meeting were Joanne Lentino, Pinellas County School Board, John Stewart, and Charles Butler. Shortly thereafter, we began collaborating with our Compatriots in the Tampa Chapter who provided significant support and assistance, and the Tampa Bay SAR Education Outreach Initiative became a well-organized, functioning reality which soon attracted the attention and cooperation of the Florida Department of Education.

The Initiative has received several assignments from the DOE, which we have either completed or are in the process of completing, including the review of Florida's textbooks and input into education standards and policy.

As a Compatriot of the St. Petersburg Chapter, you are a part of its success and can take pride in your membership. Your meeting attendance, and financial contributions are vital to the continued success of our chapter, and its agenda of state and national leadership. 
